## **ROLL CALL**

**Mayor Jeff Schroeder**, at the Community Center located at 600 Main Street, called the special meeting of the Stanhope City Council to order at 6:00 P.M. on September 27, 2023. Members answering roll call were: **Vickie Anderson, Beau Jensen, Terry Painton & Shaunna Zanker.** Members of the public present: Brian Miller, Leigh Miller, Bob McNally and Kelly Writz. **Clerk Neuberger** acted in the position of Secretary.

### CONSENT AGENDA

Motion by *Beau Jensen*, seconded by *Terry Painton*, to approve the consent agenda consisting of the following: B-1. Approval of the agenda for 09/27/2023, notice of which was published as prescribed by 1-4 .0105 (2) of the Stanhope Code of Ordinances, 2008 on 09/22/2023, Vickie Anderson-aye, Beau Jensen-aye, Shaunna Zanker and Terry Painton-aye. # OPEN PUBLIC HEARING

Motion by Beau Jensen, seconded by Terry Painton to open the public hearing on the requested building code variance to reduce the minimum front yard setback from 15 feet to 8 feet on property located at 705 School Street. Mayor Schroeder opened the public hearing on the requested building code variance. At 6:01 PM. Beau Jensen-aye, Terry Painton-aye, Shaunna Zanker-aye and Vickie Anderson-aye. Motion carried.

Clerk Neuberger stated that no written comments for or against the proposal were submitted. Beau Jensen explained what was being requested on the variance. Current code states that the setback is 15 feet from property line. This request would allow that setback to be reduced to 8 feet from the property line. The property lines are based on the road width and then measured from the center of the road. Kelly Wirtz asked where the edge of the deck would be. Brian Miller explained that the east side will be 21 feet from the road and the south side will be in line with the edge of the house.

Motion by Beau Jensen, seconded by Terry Painton to close the public hearing on the requested building code variance to reduce the minimum front yard setback from 15 feet to 8 feet on the property located at 705 School Street.
